collected 75% fees in the year 2020-21. School has paid full salary to the employees. Teachers in higher standard are not easily available. To avoid the resignation from competent teachers, school has to pay high pay scale. School has to maintain the norms of CBSE board and therefore asked 15% increase in fees. We have gone through the papers submitted by the school, considering the inflation rate hike in salary, increment of the staff it is just and reasonable to allow 10% increase over the fees determined by the FRC for the year 2019-20 and further 7% increase for each year 2022-23 and 2023-24 respectively and determine fees as under:
