1. This Proposal has been filed by applicant school to determine fees for the year 2024 - 25, 2025 - 26 & 2026 - 27.
2. Applicant school is affiliated with CBSE Board.
3. School is English medium school.
4. School is situated at. Gajera Vidhyabhavan, Katargam, Amroli Road, Surat - 395004.
5. This Proposal is for Jr. Kg. To 12(Sci.)(Com.).
6. This school is registered with 242221503178 U - dise number.
7. School has filed this proposal on 30-10-2023 to determine fees for the year 2024 - 25, 2025 - 26 & 2026 - 27.
8. As per order of Honble' High Court in special civil application no. 2352/2021 " Self Finance Schools may charge admission fees and term fees determine by the FRC subject to the limits prescribed in sec2(G) of the Act ". Therefore desecration lies with the school in respect of collection of term fees. Thus any school charge term fees over the fees determine by this committee.
9. For example a school who charge Rs. 1000/- P. M. i.e. Rs. 12000/- P. A. is entitled 2 month term fees. It stands to 16.66% increase in fees .

10. It is submitted by shri chunibhai Gajera that considering the losses in previous year 20% increase is essential. It is further submitted that 20% increase if granted he shall not charge term fees extra.

11. During hearing it is Mr. Chunibhai Gajera that the fees proposed by the school does not includes term fees. It is further submitted that school building is very old it requires huge repairing. He has submitted certificate issued by HDFC bank - Katargam branch which shows that school has paid Rs. 2,35,44,597/- towards salary. Mr. Gajera insist at least 17% increase in fees. Considering the inflation rate increments of the staff hike in salary. We think it fit to allow the same and determine the fees as under.


